



## **BABAO Privacy Information Document 2024**

### **Introduction**

The General Data Protection Regulation (GDPR) came into effect on Friday 25th May 2018. This changed the way that organisations, such as BABAO, keep information about their members. This document explains what information we hold about you, why we hold it, how we protect it for you, and how you can have your information removed from our files, if you so wish.

(On January 1st 2021 the Brexit transition period ended, and the UK left the EU. GDPR is still retained in domestic law, and so the way BABAO processes membership data has not changed. The UK received adequacy status from the EU on 21/06/2021. Any data provided to BABAO from EU members before the end of the transition period will be protected under EU GDPR and UK GDPR.)

### **What information do we hold about you and why?**

The information that we hold about you was the information that you provided when you joined BABAO on your application form. This includes:

- Title
- Full name
- Address
- Postcode
- Country
- E-mail address
- Phone number
- Membership category
- Date joined/ year of joining
- Payment records (including date of payment, amount paid, and payment method)
- Areas of interest

**Student members:**

- University affiliation
- Proof of student status

**Waged members:**

- Occupation (job title/ position)
- Affiliation (place of work)

This information enables us to keep in contact and to provide you with information about:

- Research news and queries
- Grant funding opportunities
- Conferences, seminars, and workshops
- Opportunities for collaboration
- Job opportunities
- Publication news

We keep in contact by email and may occasionally send you hard copy publications in the post, for example, Trends in Biological Anthropology. We may also contact you via social media, and by telephone, where you have given us permission to do so.

This information aids us in keeping our records up to date and provides us with the necessary information to understand the composition of the membership.

**Who do we share your personal information with?**

We will share your information only with suppliers who work on our behalf (such as Web Integrations who host the website, or Conference Organisers). The suppliers will only use personal data within the bounds of the purposes laid out in this Privacy Information Document.

**Mailing list**

Your name and email address are also registered with JISCMail, as they host the BABA mailing list. Personal data used for this mailing list are stored subject to their regulations. The BABA mailing list is used by members to inform the wider membership about:

- Research news and queries
- Grant funding opportunities
- Conferences, seminars, and workshops

- Opportunities for collaboration
- Job opportunities
- Publication news

### **How long will we keep your information?**

Information about members is updated annually in January. We will keep information for as long as necessary for the purposes it was collected for. This will vary depending on the type of information, and legal requirements or other justifications permitted by the Data Protection Law. We have an Information Retention Policy which sets out retention periods.

### **What are our responsibilities and your rights?**

We will take great care with the information that we hold about our members. As paying members of the organisation, we hold your personal data as part of our legitimate interest in aiding us to run the BABAQ.

### **Opting out**

We hope that you benefit from the information and updates circulated by BABAQ. However, you have the right to opt out of the BABAQ mailing list. To do this, please contact the Membership Secretary (Bennjamin Penny-Mason at [membership@babao.org.uk](mailto:membership@babao.org.uk)).
